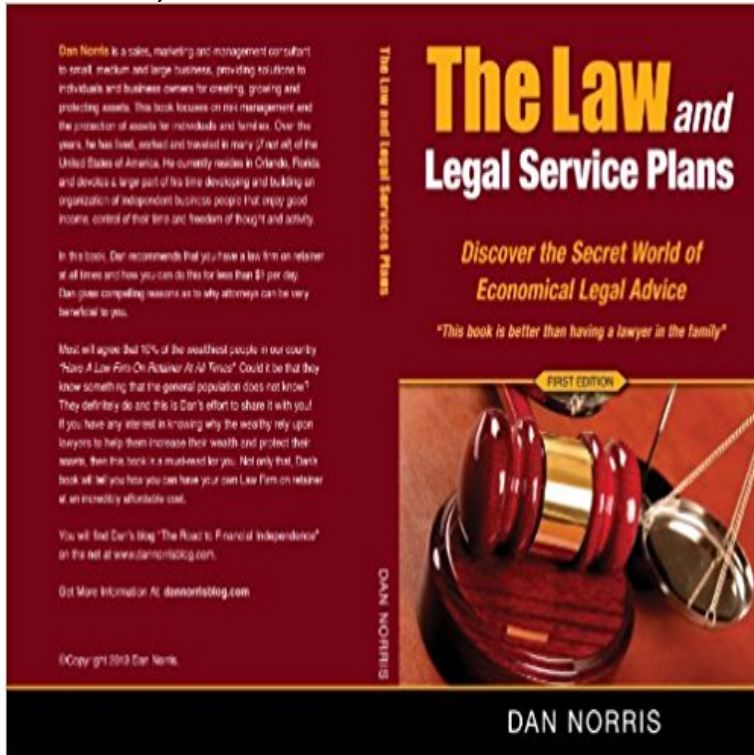


# The Law and Legal Service Plans (Road To Financial Independence Book 1)
