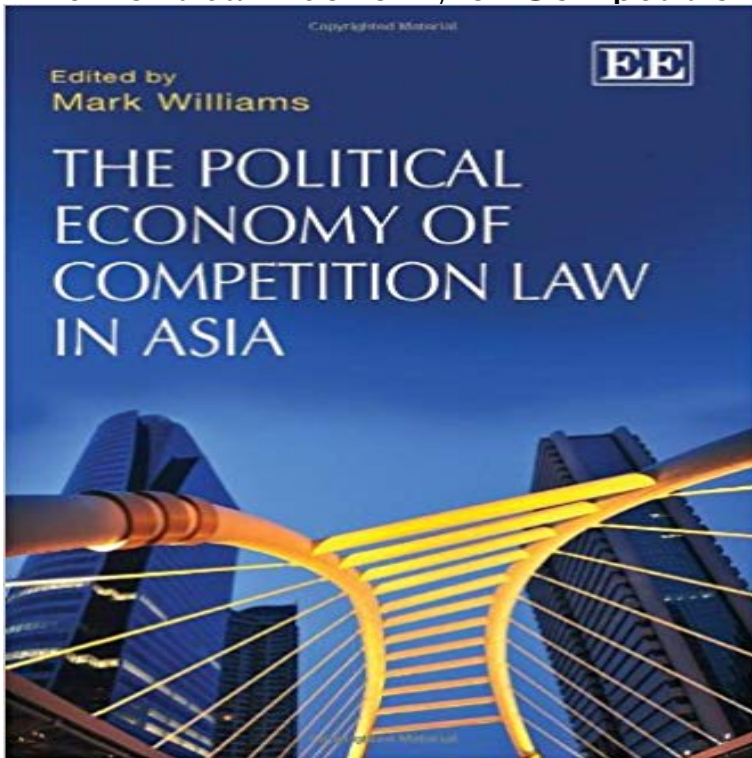


# The Political Economy of Competition Law in Asia
