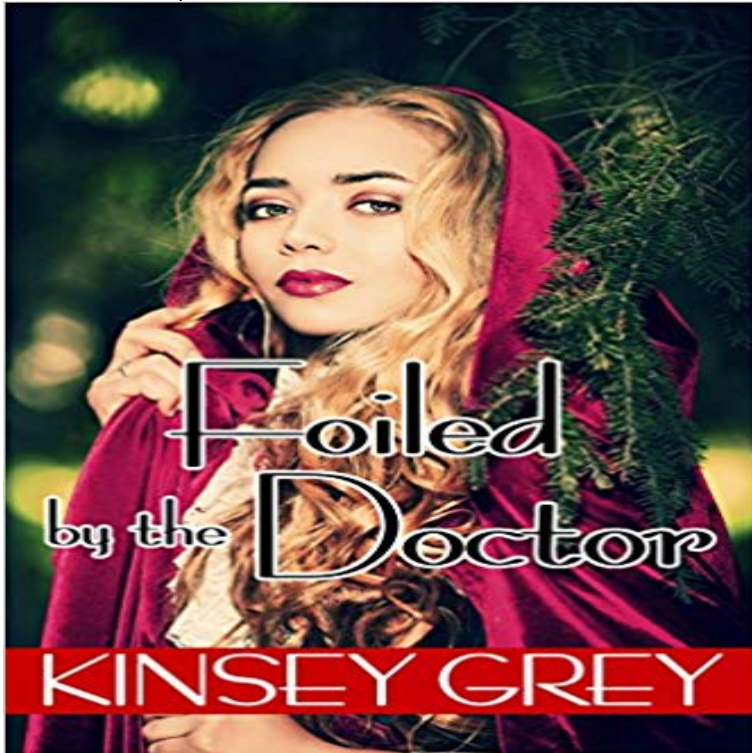


## Foiled by the Doctor: Historical Medical Submission
