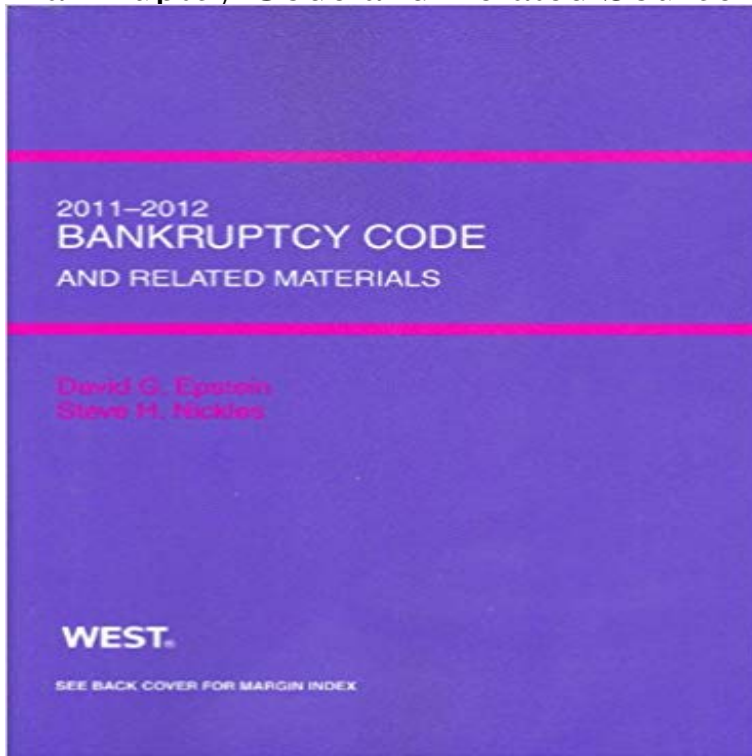


Bankruptcy Code and Related Source Materials, 2011-2012
