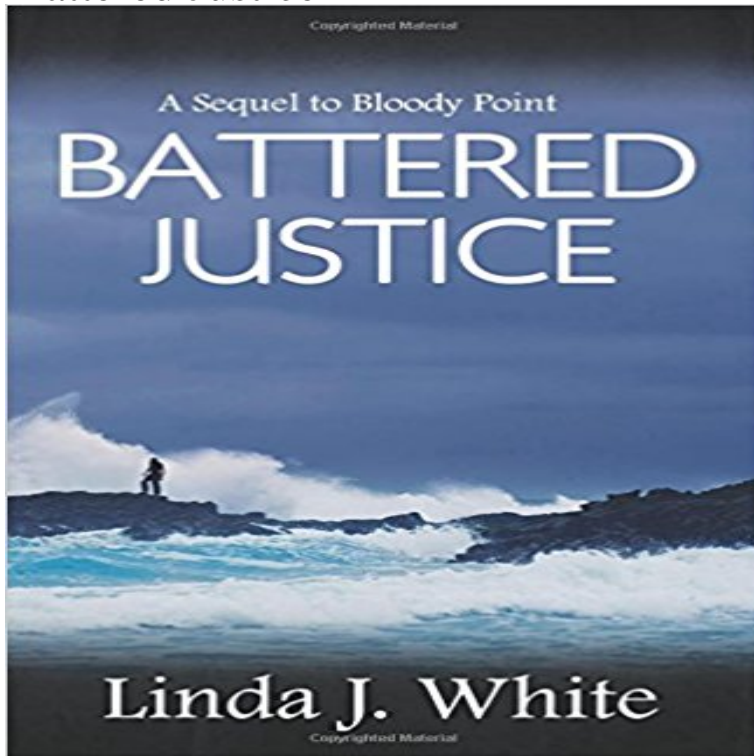


Battered Justice
