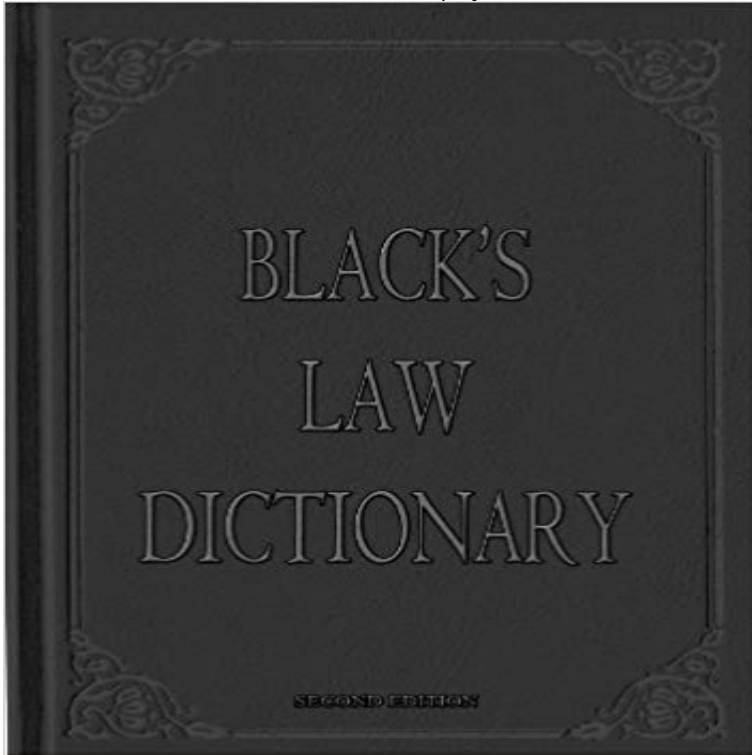


## Blacks Law Dictionary [ Second Edition]
