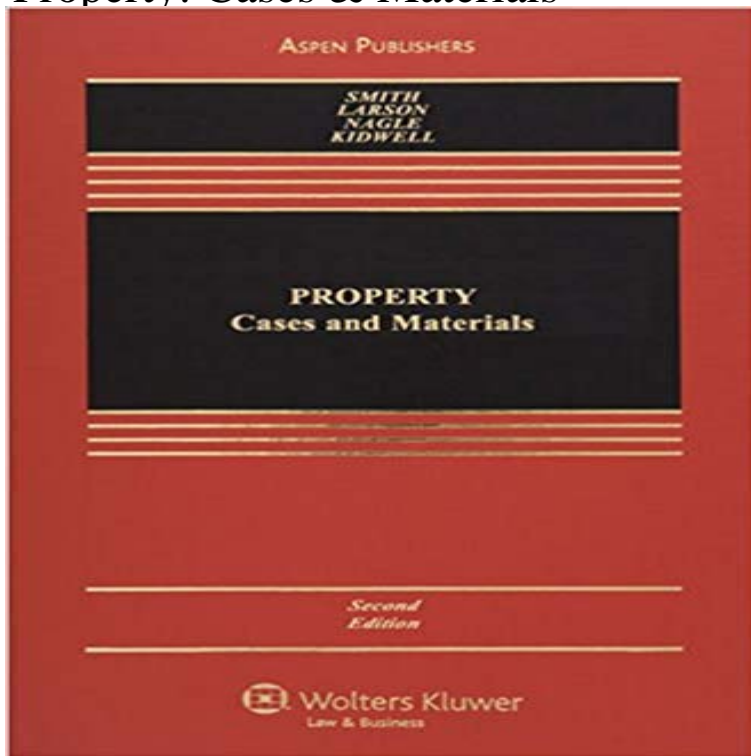


## Property: Cases & Materials
