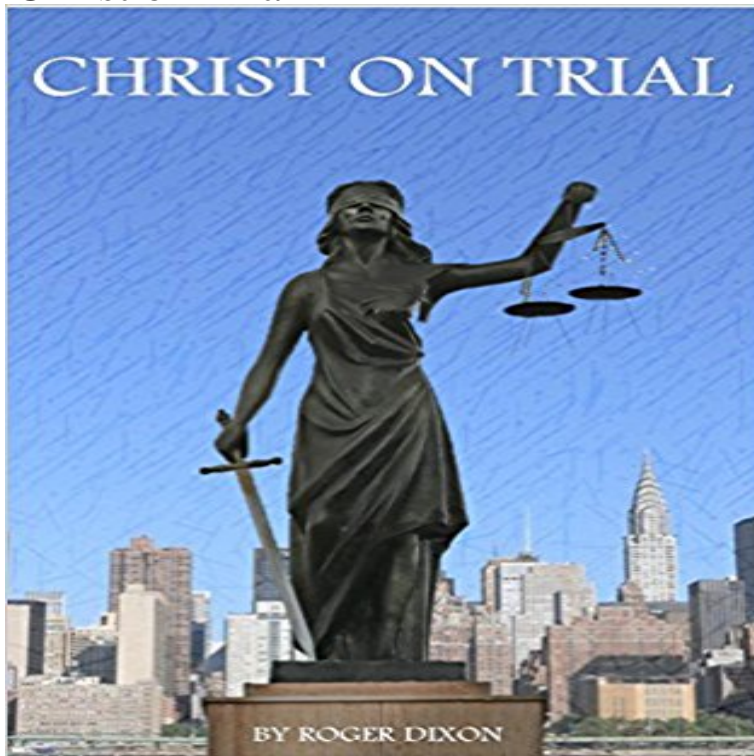


## Christ on Trial
