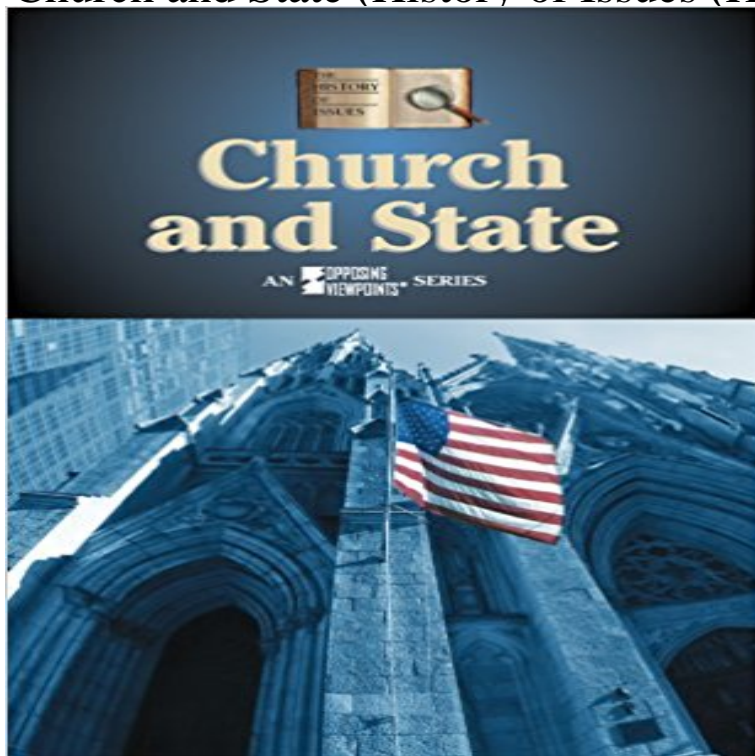


Church and State (History of Issues (Hardcover))
