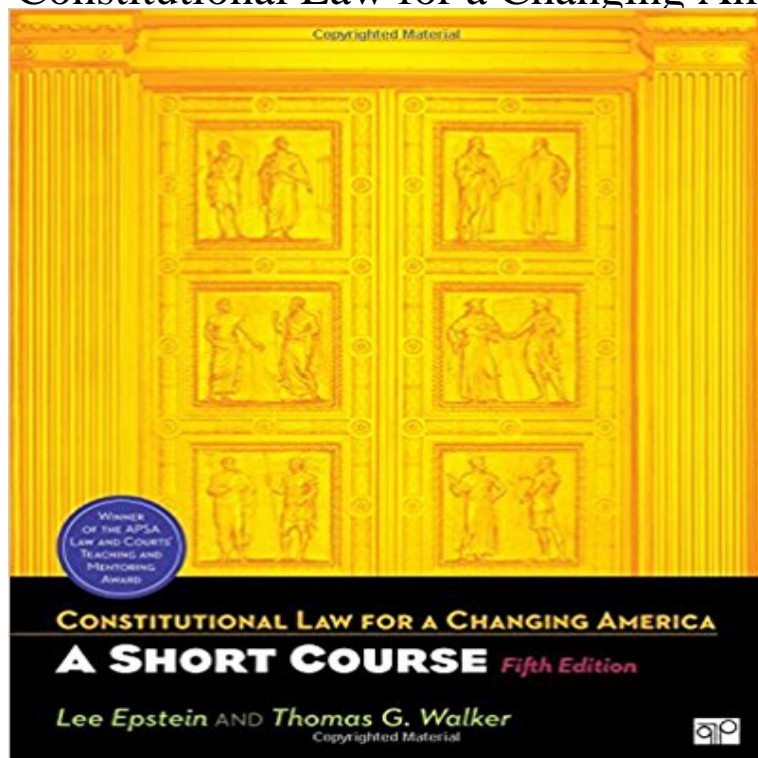


## Constitutional Law for a Changing America: A Short Course, 5th Edition
