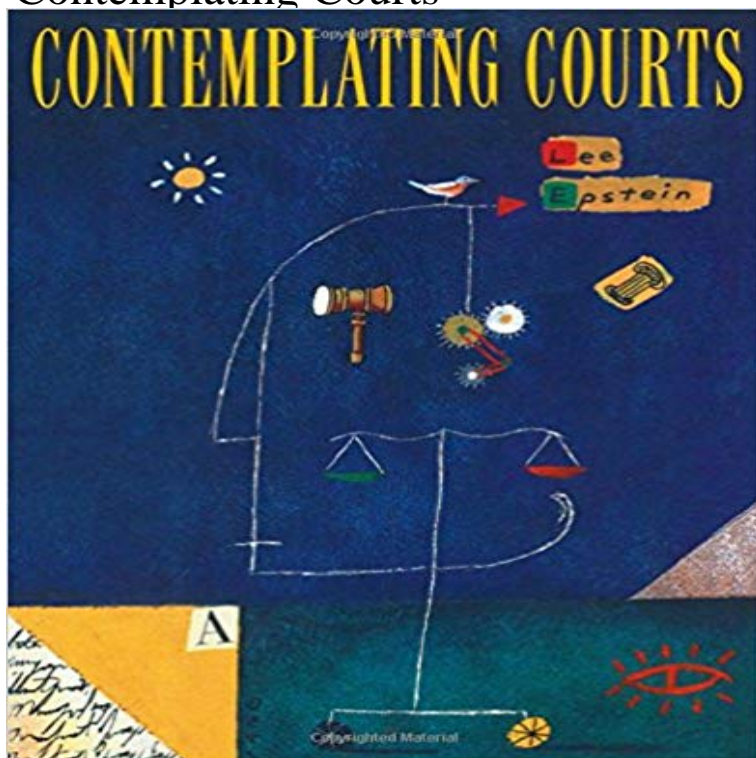


Contemplating Courts
