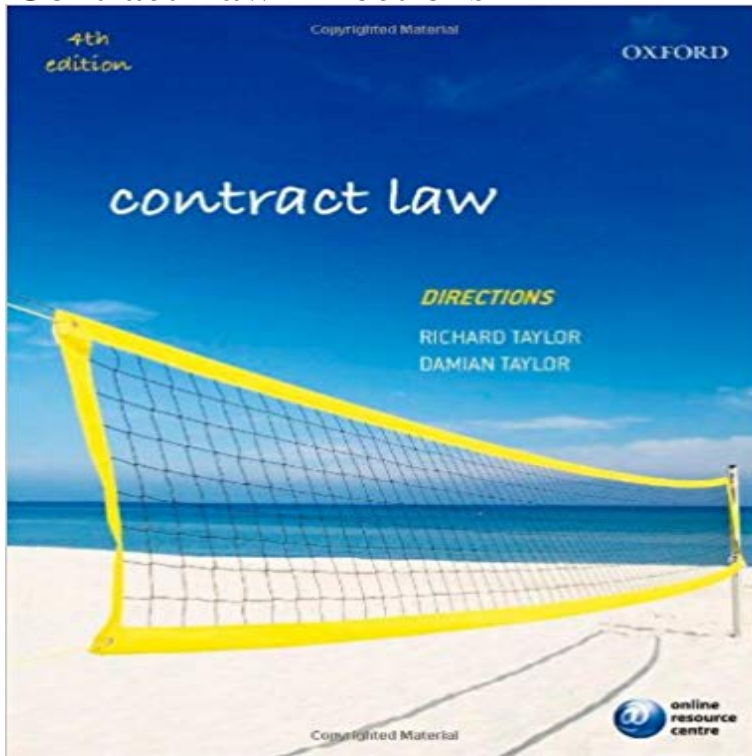


Contract Law Directions
