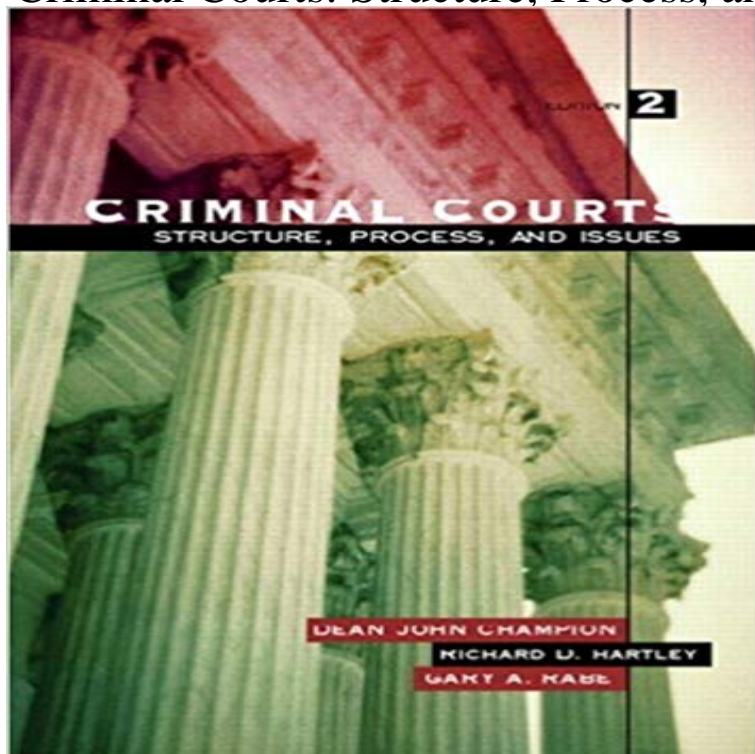


Criminal Courts: Structure, Process, and Issues (2nd Edition)
