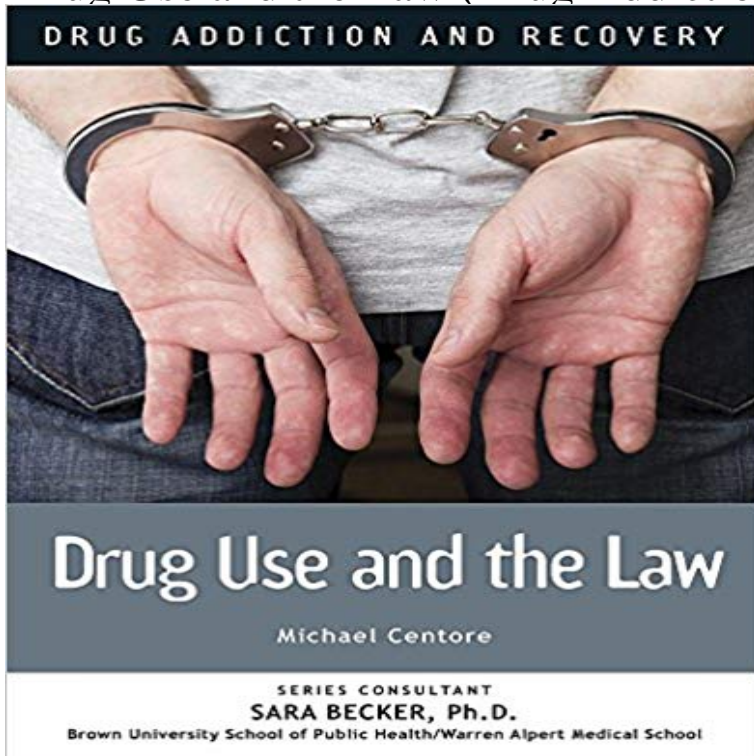


## Drug Use and the Law (Drug Addiction and Recovery)
