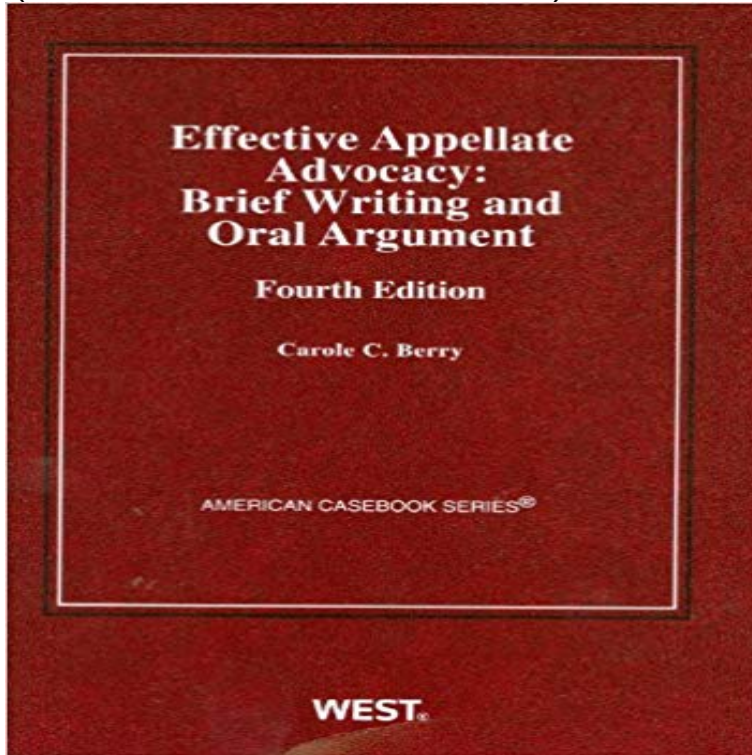


## Effective Appellate Advocacy: Brief Writing and Oral Argument, 4th (American Casebook Series)
