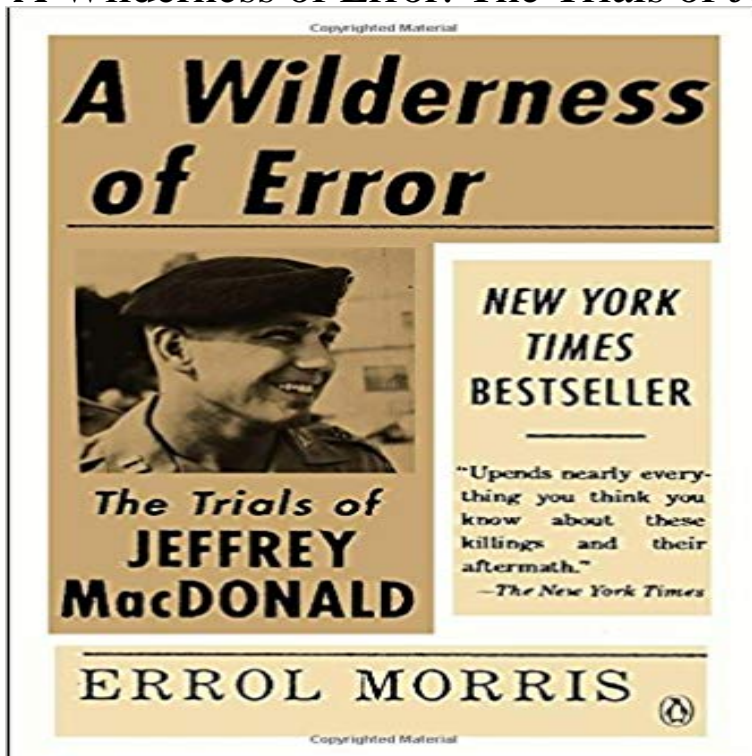


## A Wilderness of Error: The Trials of Jeffrey MacDonald
