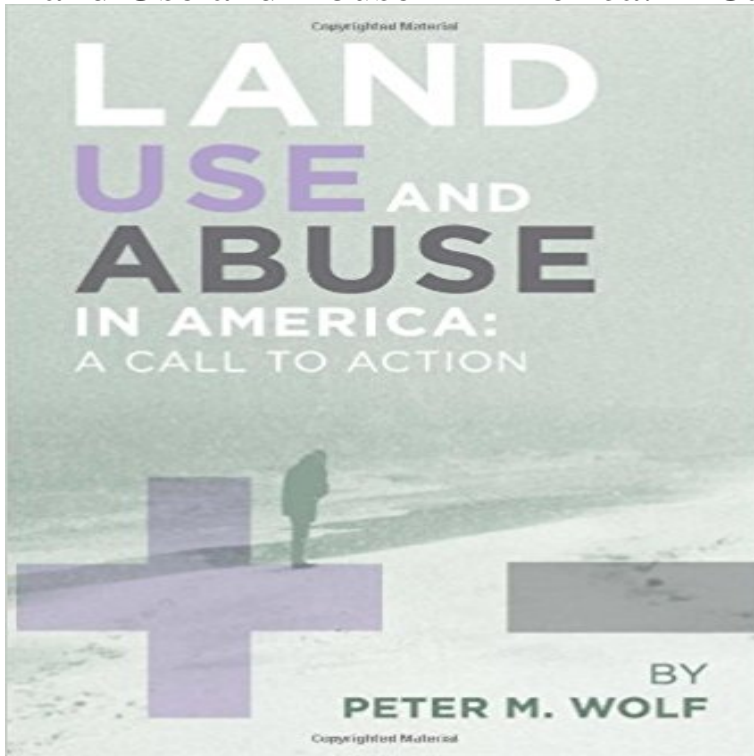


## Land Use and Abuse in America: A Call to Action
