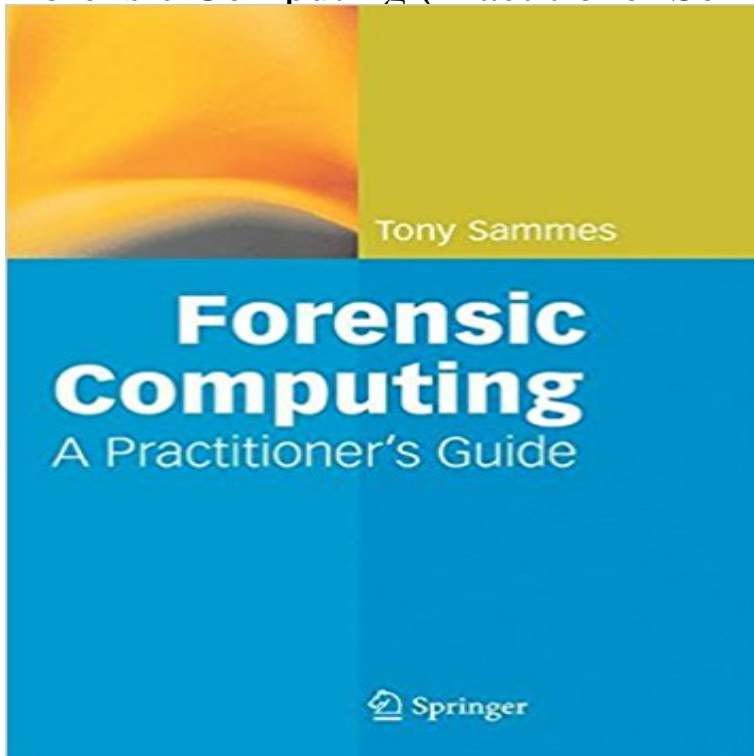


Forensic Computing (Practitioner Series)
