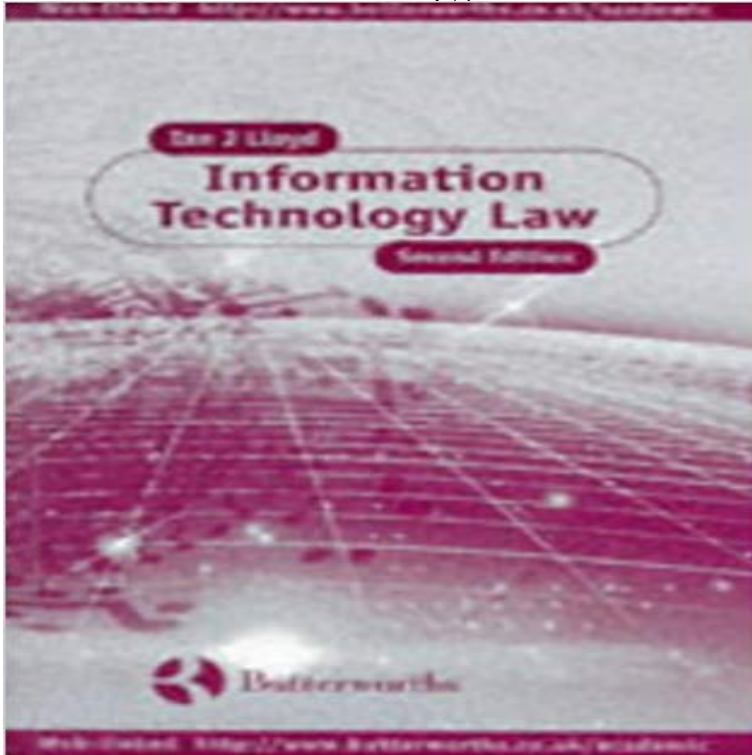


## Information Technology and the Law
