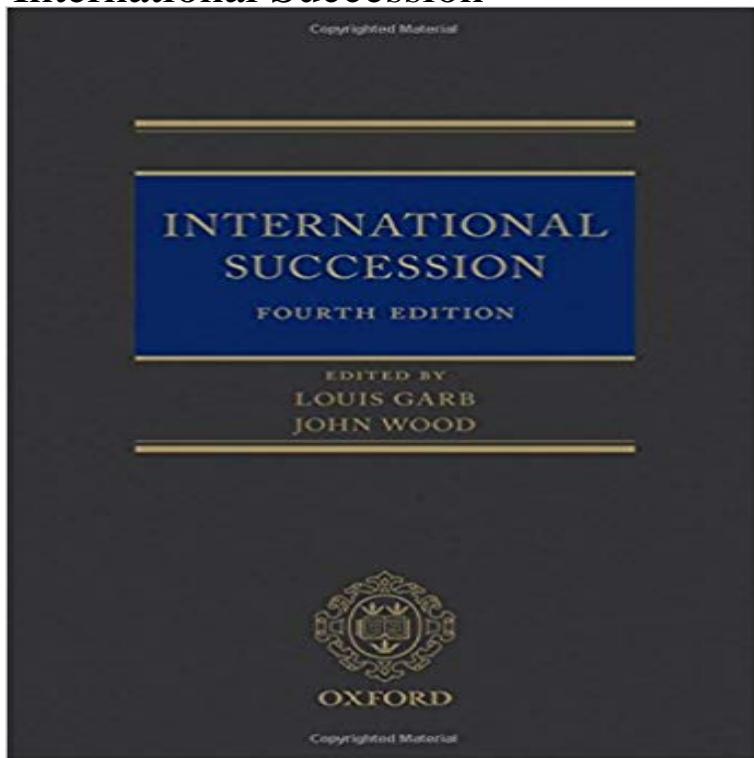


International Succession
