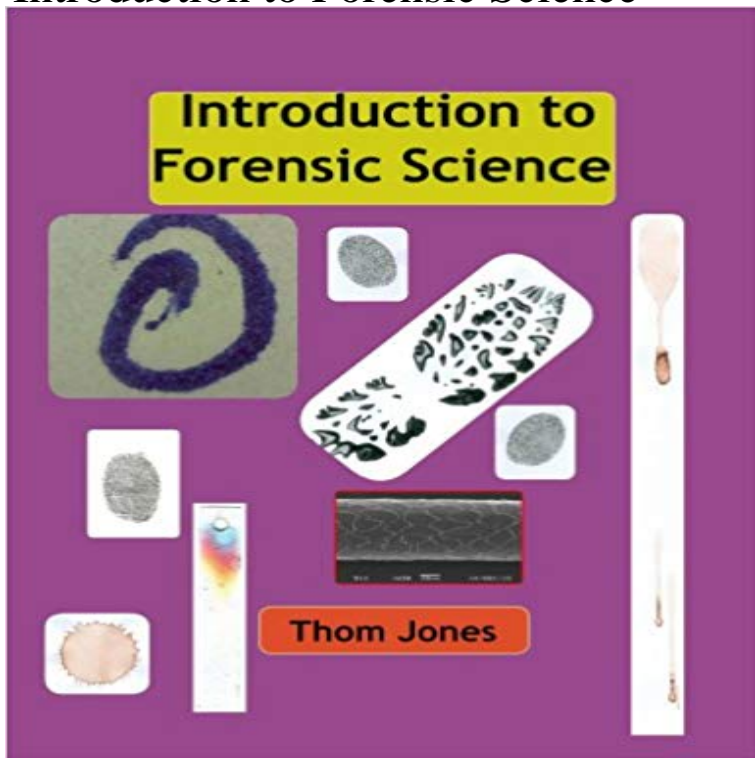


# Introduction to Forensic Science
