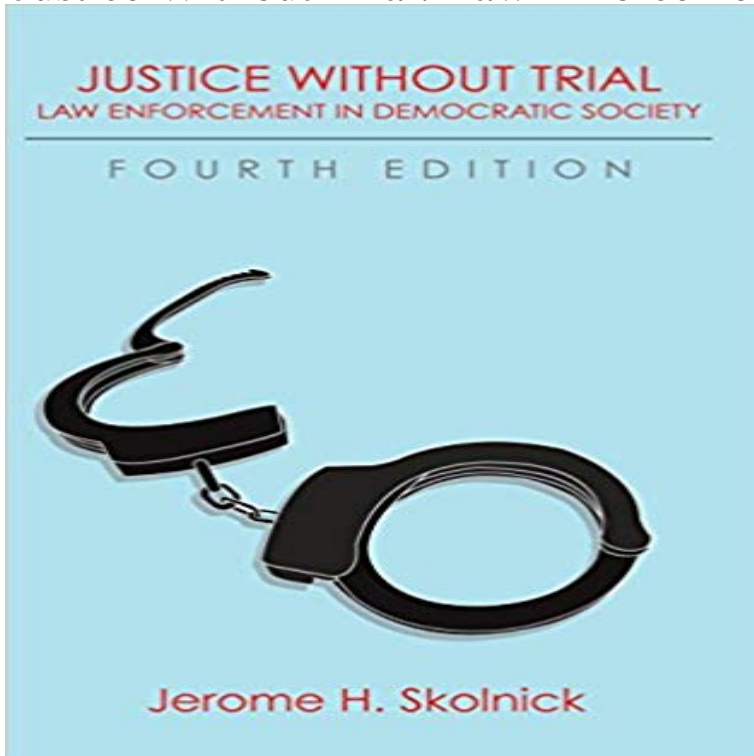


## Justice Without Trial: Law Enforcement in Democratic Society
