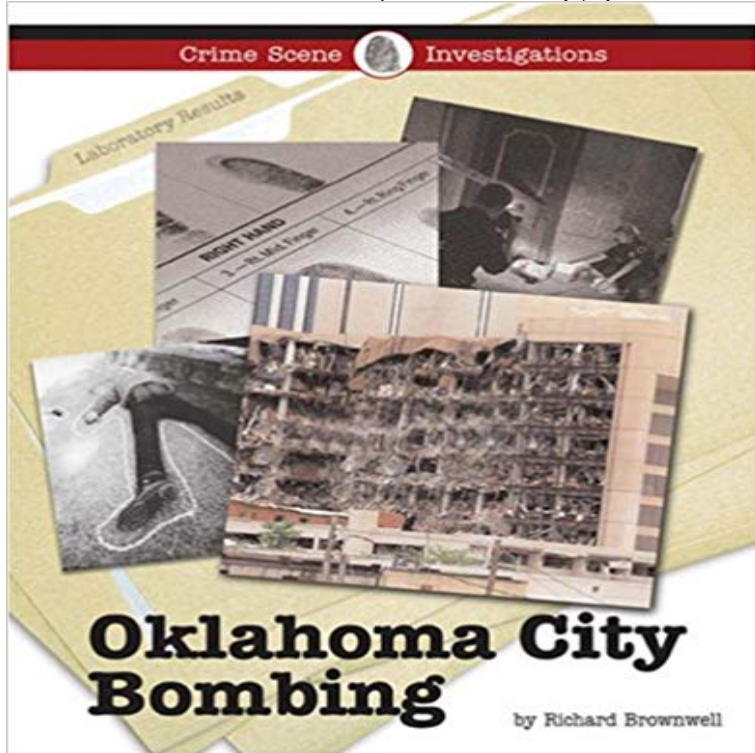


## The Oklahoma City Bombing (Crime Scene Investigations)
