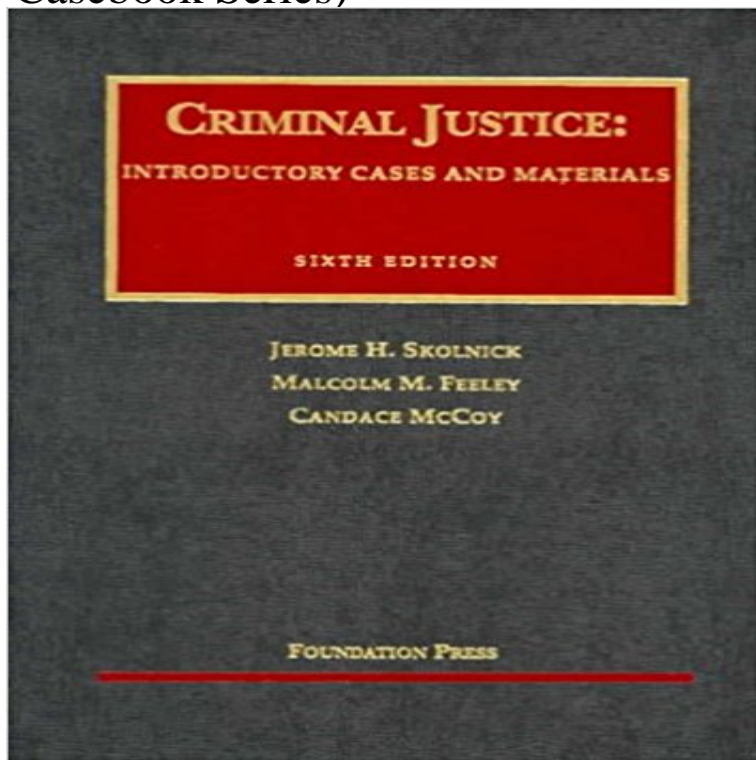


## Criminal Justice: Introductory Cases and Materials, 6th (University Casebook Series)
