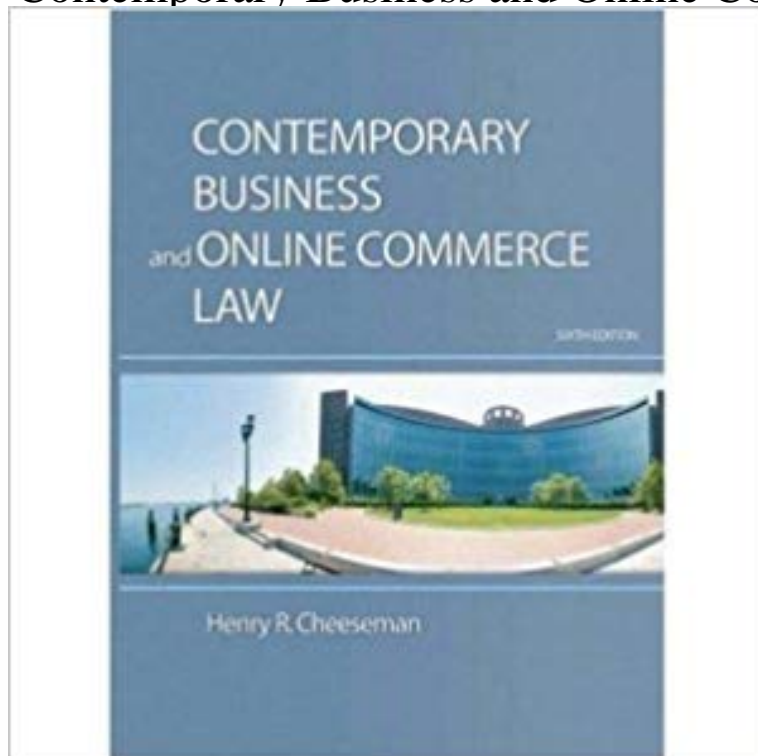


## Contemporary Business and Online Commerce Law, 6th Edition



This is a looseleaf copy of the sixth edition, prepared for use at a community college. It has an introduction, 41 chapters, an appendix, and a total of 1376 pages (ten are blank, for note-taking), and in all probability is identical to the hardcover edition. The pages have three holes each, so the pages could easily be inserted into a ring binder (or many ring binders!) I counted every chapter but not every page, but I did spot check quite a few sections and found nothing missing. The pages are free of any markings.
