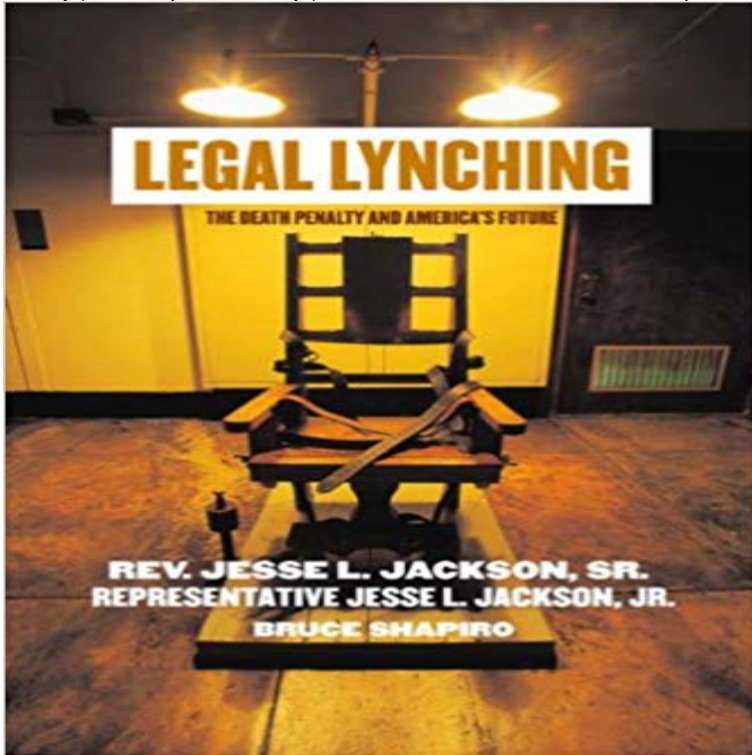


## Legal Lynching: The Death Penalty and Americas Future
