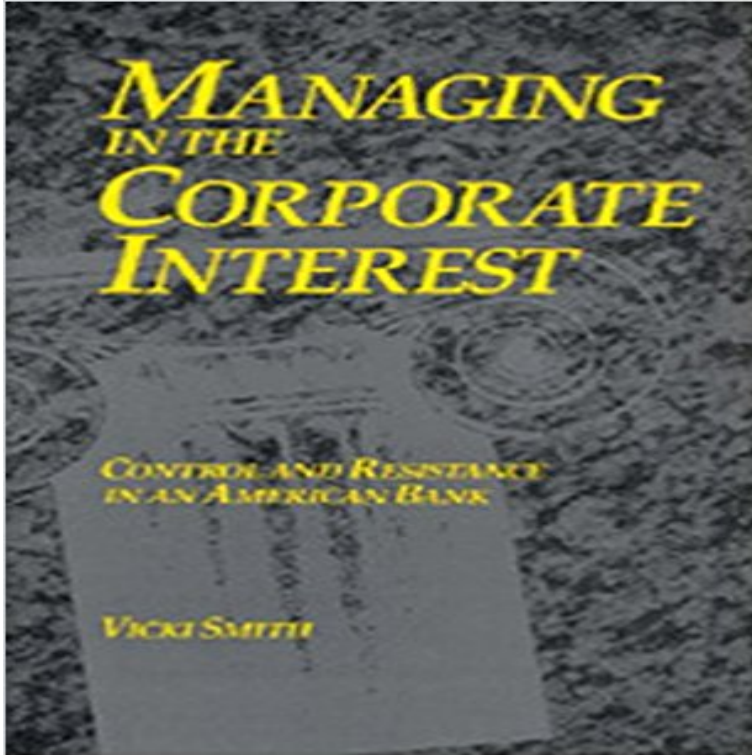


# Managing in the Corporate Interest: Control and Resistance in an American Bank
