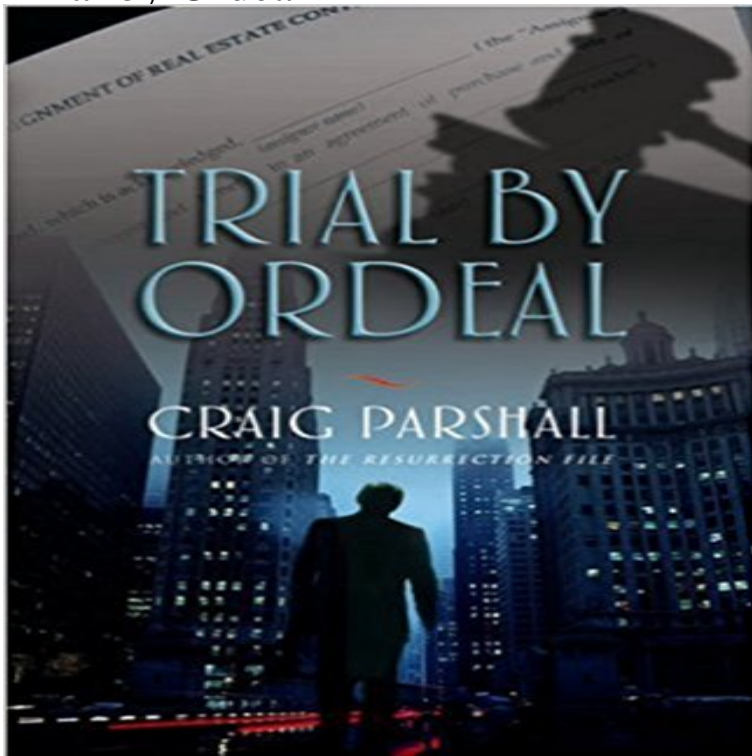


# Trial by Ordeal
