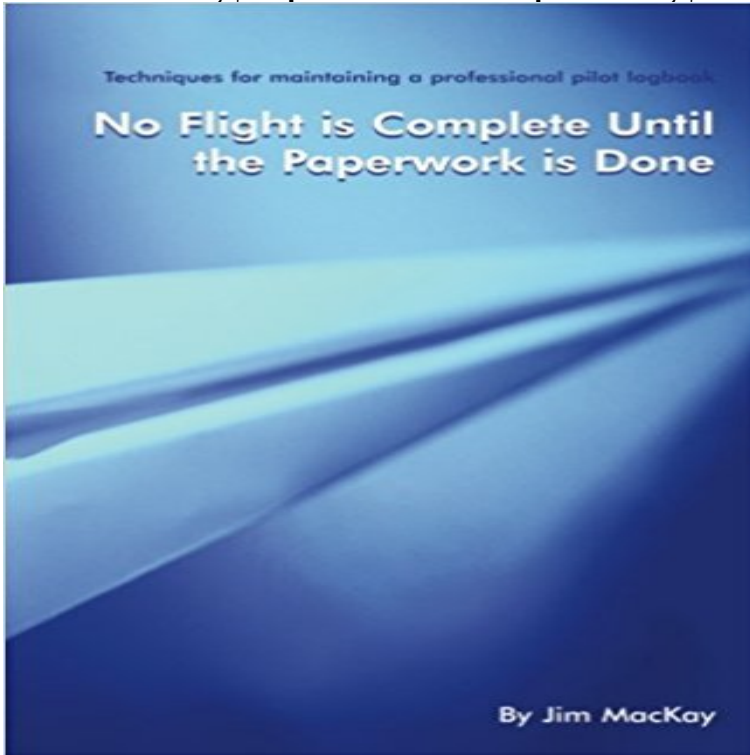


# No Flight is Complete Until the Paperwork is Done: Techniques for maintaining a professional pilot logbook
