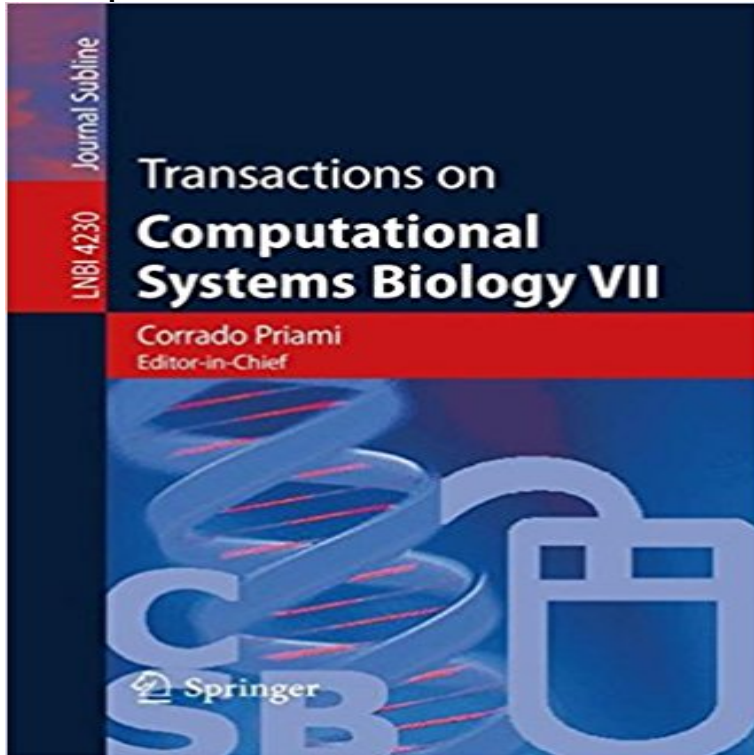


# Transactions on Computational Systems Biology VII (Lecture Notes in Computer Science / Transactions on Computational Systems Biology)
