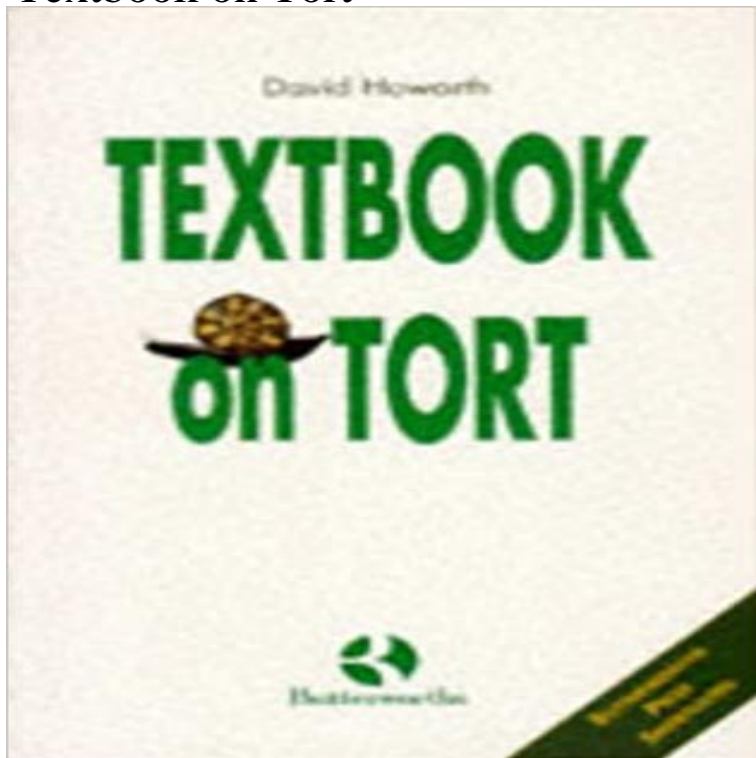


## Textbook on Tort
