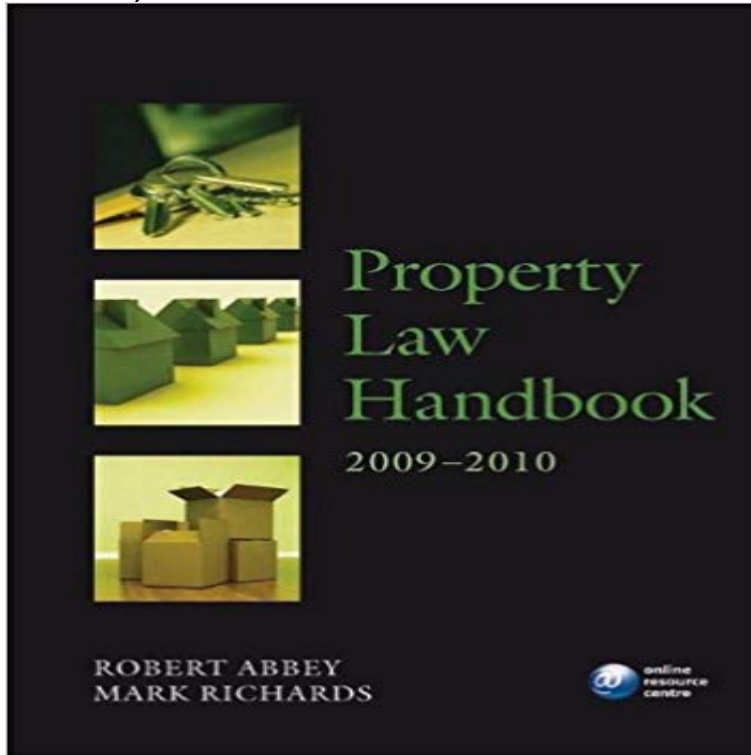


# Property Law Handbook 2009-2010 (Blackstone Legal Practice Course Guide)

For lecturers, a test bank of multiple choice questions is available and can be used to test students understanding of topics and track their progress throughout the course. The test bank can be uploaded to an institutions own virtual learning environment and can be fully customized to match the structure and content of individual courses enabling lecturers to offer their students a truly blended learning package.
