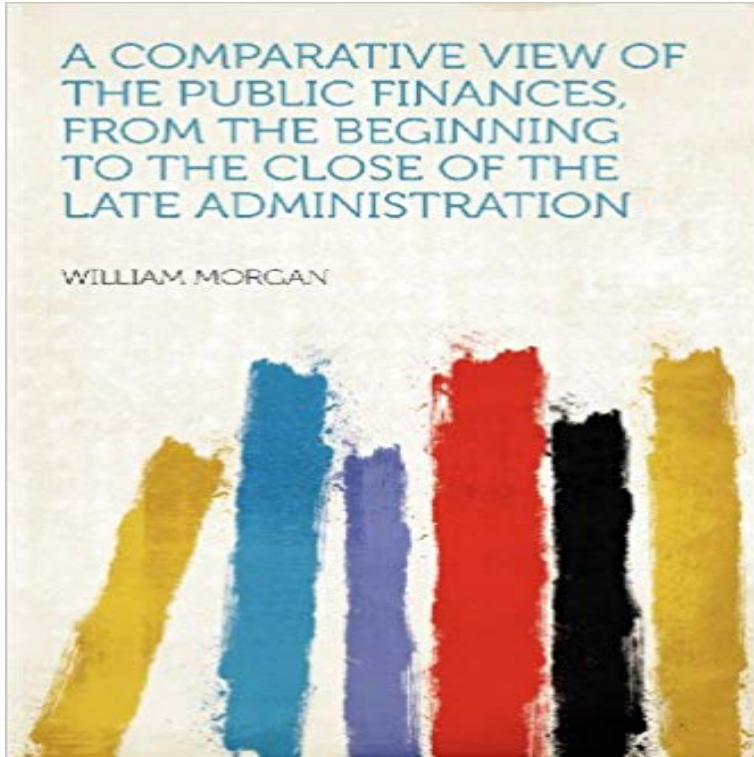


A Comparative View of the Public Finances, From the Beginning to the Close of the Late Administration
