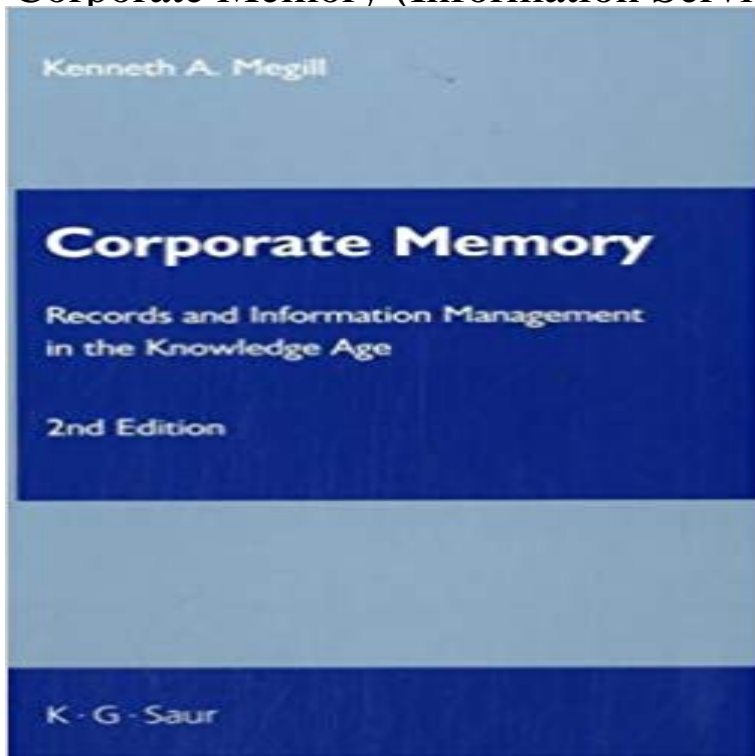


Corporate Memory (Information Services Management Series)
