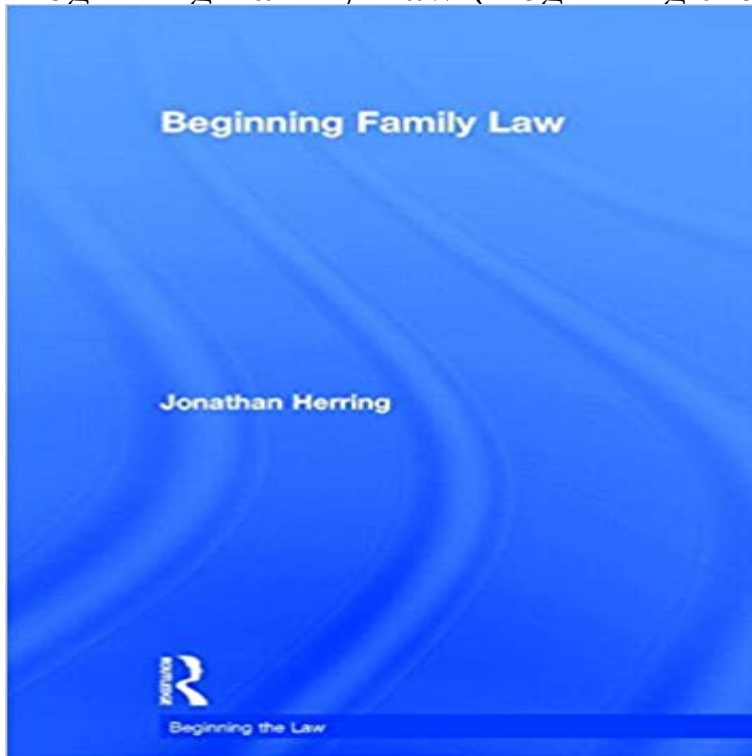


## Beginning Family Law (Beginning the Law)
