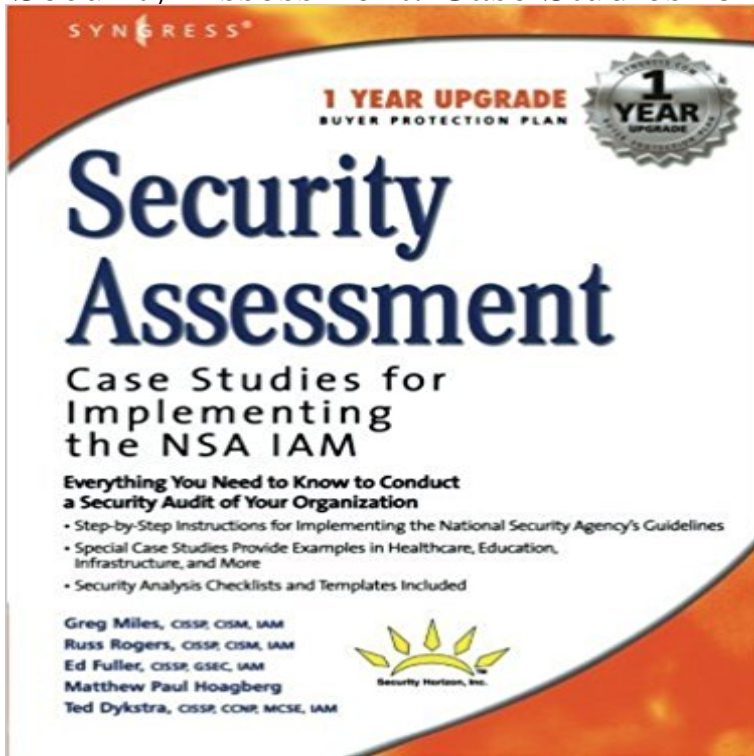


Security Assessment: Case Studies for Implementing the NSA IAM
