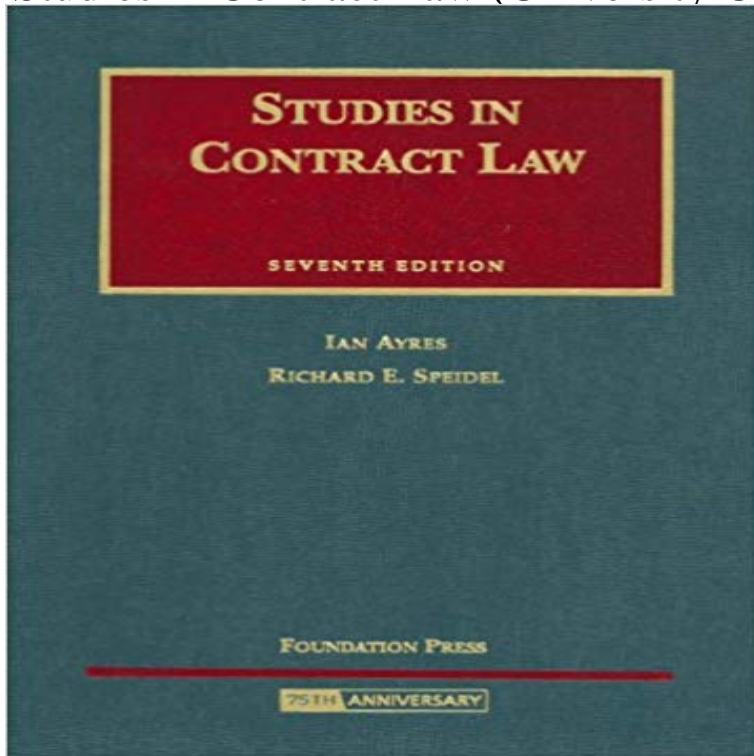


Studies in Contract Law (University Casebook)
