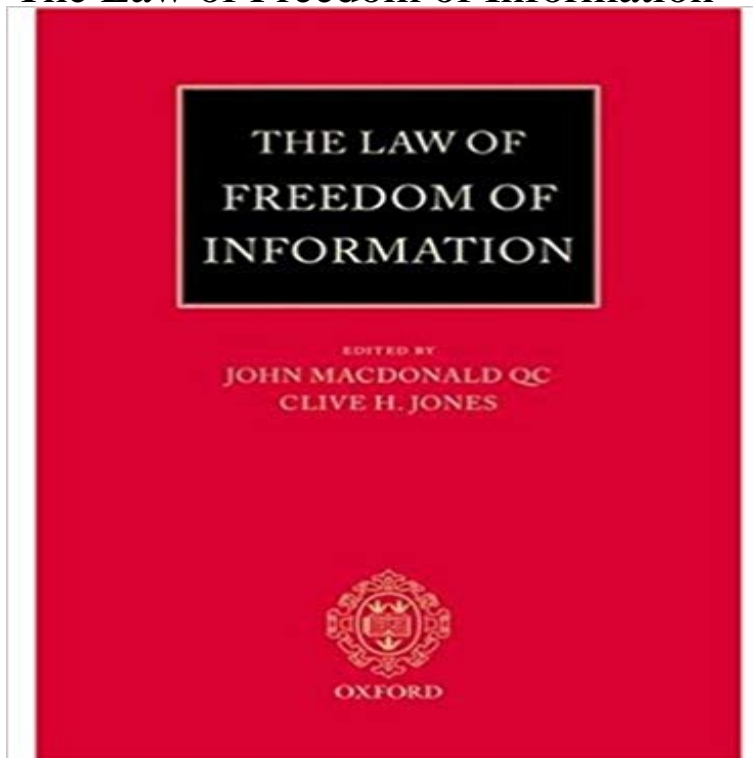


# The Law of Freedom of Information
