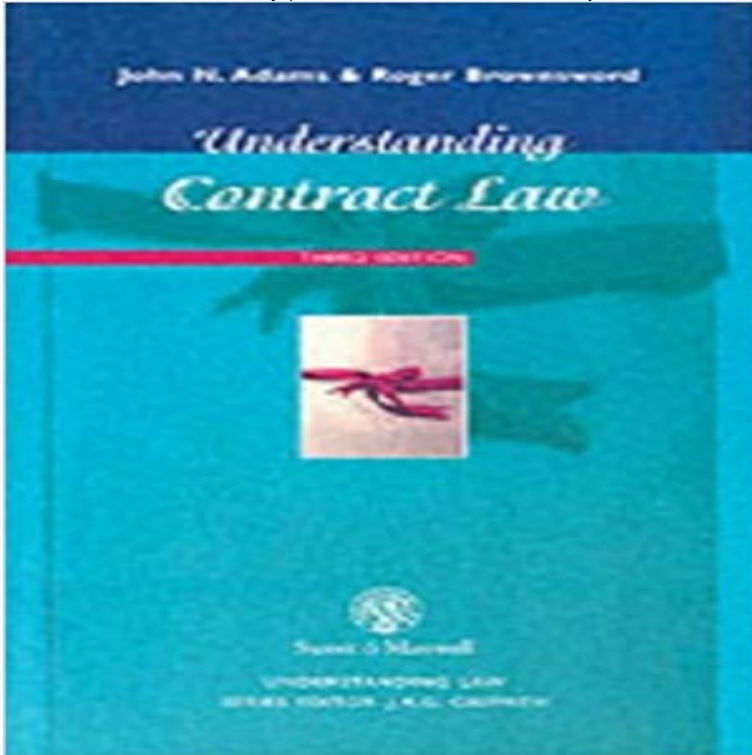


Understanding Contract Law (Understanding Law)
