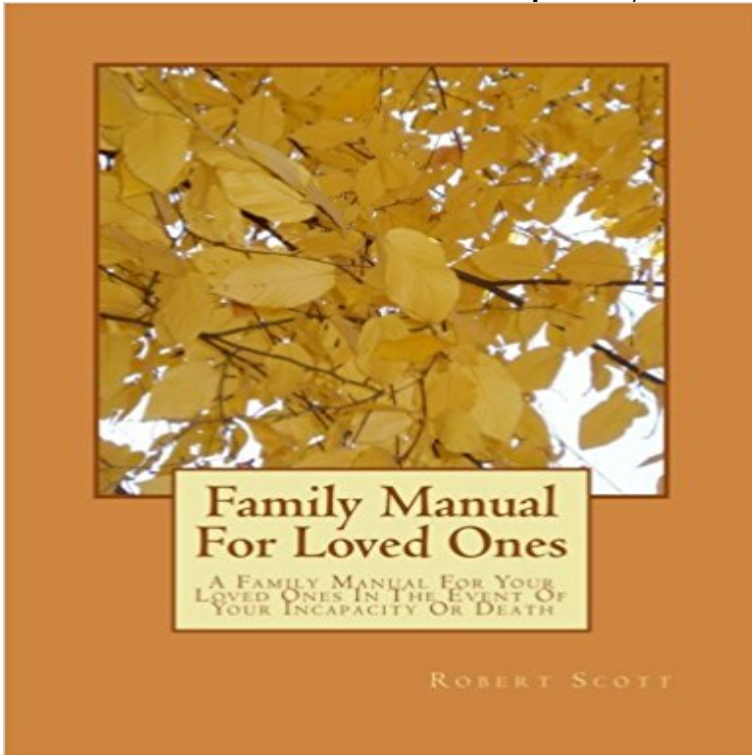


# Family Manual For Loved Ones: A Family Manual For Your Loved Ones In The Event Of Your Incapacity Or Death
