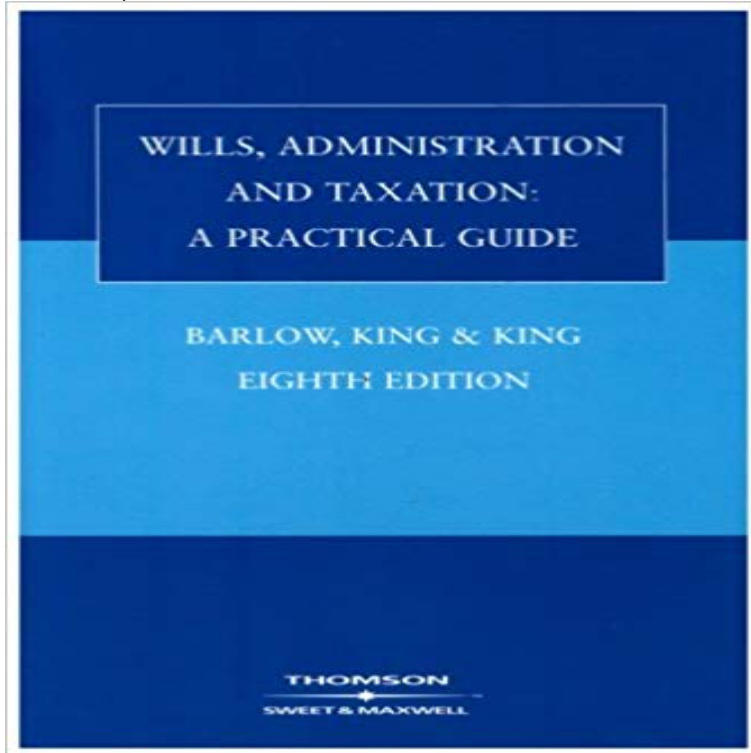


# Wills, Administration and Taxation: A Practical Guide
